**Class 1** 4-H or Independents - 200 -300lb

### **DIVISION 796**

**Class 2** FFA Market Swine - 200 - 300lb

### **MARKET HOGS SCORECARD**

**MARKET READY:** U.S. No. 1 and No. 2 hogs of average or greater conformation that are acceptable in leanness, muscularity and production traits.

**NOT MARKET READY:** Any hog of below average conformation including U.S. No. 3, U.S. No. 4 and utility grade hogs.

**DIVISION 797 - SINGLE FEEDER CLASS** - No pre-entries. Only animals not meeting weight requirements of above 199 lbs. All divisions together.

### **RULES**

- Each exhibitor should bring a short chain and combination lock to secure the animal in the pen.
- After weighing, hogs may be divided into weight lots for convenience in judging.
- Scales close at 7 pm.
- Animals will be weighed only once.

- **Must use a guard when clipping pigs before fair due to processing problems at harvest. Guidelines for trimming will be available at Fair.**
